What is redd

- An programme, which bring additional income from forestry sector through prevention of deforestation and forest degradation. Countries with high emission are potentially the buyers of carbon credit
- There are 5 activities under REDD+ :
 - 1- reducing emissions from deforestation
 - 2-reducing emissions from forest degradation
 - 3- conservation of forest carbon stocks
 - 4- sustainable management of forests
 - 5- enhancement of forest carbon stocks

- Why do we need REDD+
 - Deforestation and forest degradation contribute around 17% of global emission
 - REDD+ contribute to reduce emission and mitigate climate change
- Why do we need REDD+ implementation in Cambodia
 - Consistent to national policy and goal of RGC
 - Decision made by UNFCCC
 - provide economic social and environmental support, esp. forest and wildlife conservation

Global REDD+ status

- REDD+ is under UNFCCC
- REDD+ had been approved at COP13 (2007), COP15(2009) and COP16(2010)
- Developed countries pledge and have provided millions for supporting developing countries through bilateral and multilateral mechanisms

Cambodia REDD+ Status

- REDD+ included in the National Strategic Development Plan (2009-13) and National Forestry Programme (2010-29)
- Member of FCPF (March 2009), UN-REDD (October 2009)
- Member of REDD+ Partnership, May 2010
- 3 pilot REDD projects: Oddar Meanchey, Keo Seima(Mondulkiri), Southern Cardamom
- Development of REDD+ Roadmap

What is REDD+ Roadmap

- A plan for preparation and management of REDD+ readiness process during 3-5 years
- First step towards establishment of National REDD+ Strategy in Cambodia
- A reference for fund raising

Taskforce

- Ministry of Agriculture Forestry and Fisheries and Ministry of Environment, Ministry of Land Management, Urban Planning and Construction.
- Observers: RECOFTC and Cliton Climate Initiative
- Consultants : FAO, UNDP and UNEP
- Stakeholder consultation and representatives of civil societies and indigenous people.

Section 1: Management of REDD+ Readiness

1. National REDD+ Taskforce : Chair by Forestry Administration(FA), vice-chair General Department of Administration of Natural Conservation and Protection, members from other ministries
2. consultation group : representatives from civil societies, indigenous people, universities, NGOs, private sectors
3. Advisory group : national and international
4. Taskforce Secretariat : based at FA

Section 2: Stakeholder consultation and participation

- Step 1 : awareness raising on capacity building on REDD+
- Step2 : awareness raising, capacity building, consultation and implementation
- Step 3 : national consultation on national REDD+ strategy

Section 3: Selection of REDD+ strategies

- Selection of strategy shall consistent to existing policies and legislation, esp :
 - National forestry programme for permanent forest estate
 - National strategic planning for management of natural protected areas
 - Strategic planning for fisheries
- Other strategies consistent to decision by COP of UNFCCC

Section 4: Implementation Framework

- National and sub-national scales
- Benefit sharing mechanism
- Environmental and social assessment
- Demonstration project

Section 5: Development of Forest Reference Emissions Level

- The reference level is used for comparison to a level when REDD+ is implementing
- At least 12 years historical data on forest
- Integrate development plan in the projection

Section 6: Development of the Monitoring System

- Development of national forest monitoring system
- Forest inventory
- Remote sensing
- Reporting through UNFCCC

GRANT status

- Japanese government, 10m
- JICA, 2m for 5 years
- UN-REDD, 3m for 2 years
- FCPE, 3.6m for 3 year

Next steps

- November 2011
 - Inception workshop of UN-REDD
- December 2011: revised R-PP and submit to FCPF
- Oct-Dec 2011: establishment of National REDD+ taskforce and secretariat
- Jan-Mar 2012: Form consultation and advisory groups
