THE ESTABLISHMENT OF ALTERNATIVE CARE INSPECTION OFFICE UNDER  
CHILD WELFARE DEPARTMENT**

**Minister of Social Affairs, Veterans and Youth Rehabilitation**

- Had seen Royal Kret No NS/RKT/0704/124 dated 15 July 2004 on the Appointment of the Royal Government of the Kingdom of Cambodia
- Had seen Royal Krom No. 02/NS/94 dated 20 July 1994 which Promulgates the Law on the Establishment and Operation of Council of Ministers
- Had seen Royal Krom No. NS/RKM/0105/001 dated 17 January 2005 which promulgates the Law on the Establishment of the Ministry of Social Affairs, Veterans and Youth Rehabilitation
- Had seen Sub-Decree No. 55 ANK dated 08 April 2005 on the Establishment and Operation of the Ministry of Social Affairs, Veterans and Youth Rehabilitation
- Had seen Prakas No. 105 MoSALVY dated 27 April 2004 on the Establishment of the Alternative Care Advisory Committee
- Had seen Prakas No. 217 MoSVY dated 26 April 2006 on the Enforcement of the Policy on Alternative Care for Children
- Had seen Prakas No. 616 MoSVY dated 22 November 2006 on Minimum Standards on Residential Care for Children
- Had seen Prakas No. 198 MoSVY dated 11 March 2008 on the Minimum Standards on Alternative Care for Children in the Community
- Had seen the necessity of MoSVY

**DECIDES**

**ARTICLE 1:** Establish the Alternative Care Inspection Office under the Child Welfare Department of the Directorate of Technical Affairs.

**ARTICLE 2:** The Alternative Care Inspection Office has the following role and responsibilities:

- Monitor and evaluate the implementation of Policies and Minimum Standards related to alternative care for children
- Organize the dissemination of policies, minimum standards and other legal instruments related to alternative care for children.

- Develop guidelines and forms for the inspection team to use in the provinces/ municipalities.
- Prepare inspection plan and implement the plan.
- Produce reports for the management team of MoSVY on the results of the inspection
- Analyse the situations of children in alternative care programmes, difficulties, strengths and weaknesses in alternative care provision and provide recommendations.
- In case, the implementing institution does not make any change, raise the request to the management team of MoSVY for advises and actions.
- Maintain and update data related to alternative care for children.
- Organize and take the minutes of the meetings of the Alternative Care Advisory Committee (ACAC)
- Coordinate the technical working groups of the ACAC.
- Produce the reports on the results of ACAC activities and submit them to the management team of MoSVY.

**ARTICLE 3:** The Alternative Care Inspection Office is led by one Office Chief and a number of Deputy Chiefs who play a role assistant to the Office Chief.

**ARTICLE 4:** The Alternative Care Inspection Office shall have it own staff. If required and for the effective on the work, the Alternative Care Inspection Office may request staff of other offices under the Child Welfare Department to carry out the alternative care provider inspection.

**ARTICLE 5:** Provisions contradicting this Prakas shall be deemed null and void.

**ARTICLE 6:** Director of Minster’s Cabinet, Director-General of Directorate of Administration and Finance, Director-General of Directorate of Technical Affairs, Director of Administration and Personnel Department, Director of Finance and Supply Department, Director of Child Welfare Department shall be obliged to implement the Prakas from the date of signing.
