JOINT-PRAKAS  
ON  
THE WORK PERMIT AND EMPLOYMENT CARD FEES

The Minister of Economy and Finance  
and  
The Secretary of State of Social Affairs, Labour and Veteran Affairs

- Referring to the 1993 Constitution of the Kingdom of Cambodia;
- Referring to Reach Kram No. CS/RKM/0397/01 of March 13, 1997 promulgating the Labour Law;
- Referring to Reach Kret of November 1, 1993 on the formation of the Royal Government of Cambodia;
- Referring to Reach Kram 02/NS/94 of July 20, 1994 promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Referring to Reach Kret No. NS/RKT/1094/90 of October 31, 1994 on the Reorganization of the Composition of the Royal Government of Cambodia.

**IT IS HEREBY DECIDED**

Article 1:

The fees of the work permit and the employment card shall be set as follow:

- The fee of each employment card of Cambodian national shall be set at One thousand and five hundred riels (1,500) Riels. The fee shall be a one time payment.
- The fee of each employment card of foreign national on a temporary work shall be set at One Hundred (100.00) United States dollars.
- The fee of each employment card of a permanent foreign national shall be set at Fifty (50.00) United States dollars.

Foreign nationals shall pay their fees not later than the 31st day of March of each year.

Article 2:

These fees shall be for the account of the national budget and a receipt shall be issued to the person making the payment in compliance with the Financial Law. In Phnom Penh, the treasury agent of the Ministry of Social Affairs, Labour and Veteran Affairs shall deposit these fees to the national treasury.

The provincial and municipal Inspectorate of Social Affairs, Labour and Veteran Affairs shall deposit these fees to the respective provincial and municipal treasury.

Article 3:

The Director of the Cabinet, the Director of the Department of Employment and Manpower, the city and provincial Inspectorate of Social Affairs, Labour and Veteran Affairs of the Ministry of Social Affairs, Labour and Veteran Affairs, the Director of the National Treasury, the Director of Tax Department of the Ministry of Economy and Finance shall respectively implement this Joint Prakas.

Article 4:

The Joint Prakas of the Ministry of Economy and finance and the Ministry of Social Affairs, Labour and Veteran Affairs No. 139 MOSALVA of February 9, 1996 shall be declared null and void.

Article 5:

This Joint Prakas shall take effect as of the date of its signature.
