LABOUR DISPUTE SETTLEMENT**

The Ministry of Social Affairs, Labour, Vocational Training and Youth Rehabilitation inform owners and directors of enterprises/establishments, workers and professional organizations covered by the Labour Law and whose workplace is located in Phnom Penh that from now on when either individual or collective labour disputes occur they should notify to or lodge the complaint with the Labour Inspection Post where the enterprise or establishment is located in order that the Labour Inspector of such Post can consider and settle the dispute in an expeditious manner. Attached to this Circular is an annex listing addresses of those Labour Inspection Posts.

The Ministry of Social Affairs, Labour, Vocational Training and Youth Rehabilitation strongly hopes that the owners and directors of enterprises or establishments, workers and professional organizations whose workplace is located in Phnom Penh will pay close attention in implementing the above substance in an effective manner.
