ANUKRET on Establishment of The Fee for Stamp tax and Civil Status Forms

- Referring to the Constitution of the Kingdom of Cambodia,
- Referring to Preah Reach Kret No. NS/RKT/1198/72 of November 30, 1998 on the Establishment of the Royal Government of Cambodia,
- Referring to Preah Reach Kram No. 02/NS/94 of July 20, 1994, promulgating the Law on the organization and functioning of the Council of Ministers
- Referring to Decree No. 23D of February 15, 1991 promulgated the Law *on Stamp tax*,
- Referring to Preah Reach Kram NS/RKM/0301/05 of March 19, 2001 promulgating the law on the Commune/Sangkat Administrative Management,
- Referring to Anukret No 76 ANK/BK of October 11, 1995 on the Improvement and Supplementation to Anukret on Stamp Tax Collection;
- Referring to Anukret No 103 ANK/BK of December 29, 2000 on the Civil Status;
- Referring to Preah Reach Kram No. NS/RKM/0196/08 of January 24, 1996, promulgated the Law on the Establishment of the Ministry of Interior,
- Referring to Preah Reach Kram No. NS/RKM/0196/05 of January 24. 1996, promulgated the Law on the Establishment of the Ministry of Economy and Finance,
- Referring to Preah Reach Kret No NS/RKT/0501/175 of May 18, 2001 on the establishment on the National Committee to Support Commune/Sangkat,
- Pursuant to the need of the Royal Government of Cambodia;

DECIDES

Article 1:

All civil status forms shall be established as follow:

A- For Rattanakiri, Mondulkiri, Steoung Treng, Preah Vihear, and Ordor Meanchey:

| • Marriage certificate | 100 riels/page |
| • Certified marriage certificate | 100 riels/page |
| • Birth Certificate | 100 riels/page |
| • Death Certificate | 100 riels/page |
| • All types of copied certificates | 100 riels/page |

B- Other other than the above 4 mentioned provinces

| • Marriage certificate | 400 riels/page |
| • Certified marriage certificate | 400 riels/page |
| • Birth Certificate | 400 riels/page |

Article 2:

The fee for stamp tax stickled on the civil status forms shall be determined as follow:

| • Application for marriage | 100 riels/page |
| • Duplicated or extract of birth certificate | 300 riels/page |
| • Duplicated or certified extract of birth certificate | 300 riels/page |
| • Duplicated or extract of marriage certificate | 1,500 riels/page |
| • Duplicated or certified extract of marriage certificate | 1,500 riels/page |
| • Duplicated or extract of death certificate | 400 riels/page |
| • Duplicated or certified extract of death certificate | 400 riels/page |

Article 3:

All income collected by the Commen/Sangkat from selling all the abovementioned forms as stated in Article 1 shall be considered as direct income of the Commune/Sangkat's budget.

Article 4:

The Ministry of Interior has duty to print all of the abovementioned forms and provide to the all authorities who are in charge of civil status registration.

Article 5:

Pursuant to the spirit of this Anukret, the Minister of Interior and the Minister of Economy and Finance shall issues an additional implementation instruction if needed.

Article 6:

Any provisions contrary to this Anukret shall be considered as null and void.

Article 8:

This Anukret enters into force from the date of its signature.
