DECIDES

- **ARTICLE 1:** Adjust and supplement the composition, roles and functions of the National Multi-Sectoral Orphans and Vulnerable Children Task Force (NOVCTF) to effectively respond to the concrete situation of Orphans, Children affected by HIV and other Vulnerable Children in Cambodia (OVC).
- **ARTICLE 2:** The NOVCTF is under direct guidance of Minister of Social Affairs, Veterans and Youth Rehabilitation.

ARTICLE 4: The roles and responsibilities of the NOVCTF are as follows:

- Promote and coordinate the implementation of the National Plan of Action for OVC (2008-2010), monitor progress, identify gaps and priorities, and recommend modifications as necessary to improve the national response.
- Promote and facilitate collaboration, discussion and information sharing among key government and non-government stakeholders working with OVC.
- Monitor and assess the situation of OVC and recommend specific actions to address any policies, legal frameworks, standards, guidelines and service gaps.
- Advocate for, advice on, and facilitate the provision of quality family and community-based services for OVC.
- Provide comment and feedback to national bodies that promote and monitor the implementation of thematic strategic plans in relation to OVC e.g. National Strategic Plan (NSP) for a Comprehensive & Multi-Sectoral Response to HIV/AIDS of National AIDS Authority for 2006-2010, Work Platform of MoSVY for 2008-2013, Alternative Care Policy for children of MoSVY and strategic plans as well as work platforms of other Ministries and Institutions in relation to OVC.
- Facilitate resource mobilization for OVC-related services, especially where there are critical gaps.
- ARTICLE 5: In addition to discharging joint responsibilities of NOVCTF as described in Article 4, each NOVCTF's Member has its own duties as follows:
 - Monitor and promote the implementation of strategic plan and work platform of its Ministry, Institution or Organization which are related to OVC to contribute to the successful implementation of the NPA 2008-2010.
 - Report to the management and relevant staff of its Ministry. Institution or Organization on achievements, challenges, evaluation and recommendations of the NOVCTF.
 - Provide comments to its Ministry, Institution and Organization on all issues related to OVC.
 - Report to NOVCTF on works results, challenges and recommendations of its Ministry, Institution or Organization on all issues related to OVC.
 - Responsibly participate in all meetings of NOVCTF,
 - Assume other duties as entrusted by the NOVCTF's Chairman.
- **ARTICLE 6:** The NOVCTF has its Secretariat established at the Ministry of Social Affairs, Veterans and Youth Rehabilitation. This Secretariat is under direct direction of NOVCTF's chairman.
- **ARTICLE 7:** The NOVCTF can set up different sub- committees and working groups to help discharge its roles and responsibilities.

Unofficial Translation

- ARTICLE 8: The NOVCTF shall meet quarterly or as often as needed. All NOVCTF Meetings shall be presided over by NOVCTF's Chairman or in case of absence of the latter, by a NOVCTF's Vice-Chairman duly appointed by NOVCTF's Chairman. NOVCTF Members who can't attend a NOVCTF Meeting must appoint consistent and regular replacements according to the name lists which have been sent to NOVCTF's Secretariat.
- **ARTICLE 9:** The NOVCTF's Chairman, after consulting all NOVCTF's Vice-Chairmen, can invite representatives from other relevant Ministries, Institutions and Organizations to attend NOVCTF's meetings as deemed necessary.
- **ARTICLE 10:** The CNCC, all relevant MoSVY Departments at national, municipal and provincial levels shall coordinate their works to promote exchanges of information and experiences, and provide good conditions to the NOVCTF so that the latter can participate in their respective activities which are related to OVC.
 - The Department of Planning, Statistics and Recapitulation of MoSVY shall include NOVCTF's activities in MoSVY's reports.
- **ARTICLE 11:** Membership of the NOVCTF can be reviewed as necessary to enhance the effectiveness of the NOVCTF's work.
- ARTICLE 12: NOVCTF shall further establish its working rules.
- **ARTICLE 13:** PRAKAS N° 384 MoSVY dated 10 July 2006 and PRAKAS No 526 MoSVY dated 18 August 2008 shall be abrogated.
- ARTICLE 14: Cabinet of the Minister, Directorate of Administration and Finance, Directorate of Technical Affairs, Department of Child Welfare, Department of Social Welfare, Department of Youth Rehabilitation, Department of Planning, Statistics and Recapitulation, Excellencies, ladies and gentlemen whose names mentioned in Article 3 have the duties to effectively implement this Prakas from the date of signing.
