- Facilitating regional collaboration and the management of shared natural capital
 - Support regional dialogue and policy directives through WGE meetings, SOM, EMM
 - Identify and develop projects with regional or transboundary scale and impact
 - Establish regional centers of excellence/ community of practice to provide services for select thematic areas and related activities



- Providing in-country policy advise and technical support in the areas of sustainable infrastructure, natural capital and climate change
 - Assist in developing national strategic plans integrating environment and climate change
 - Support strengthening of national safeguard systems and environmental monitoring and compliance capacity
 - Advise on legal and regulatory frameworks
 - Support development of suitable fiscal mechanisms



- Providing information and knowledge management support
 - Knowledge events and publications facilitating policy-science linkages
 - Enhance an online portal to facilitate project readiness and strategic decision support by providing information on:
 - Key statistics
 - Assessments to support project formulation
 - Planning and decision support tools
 - Experiences and best practices

- Providing project development, financing and investment services
 - Establish a project preparation facility
 - Undertake financial feasibility studies
 - Develop and stimulate private sector/ PPP investment opportunities

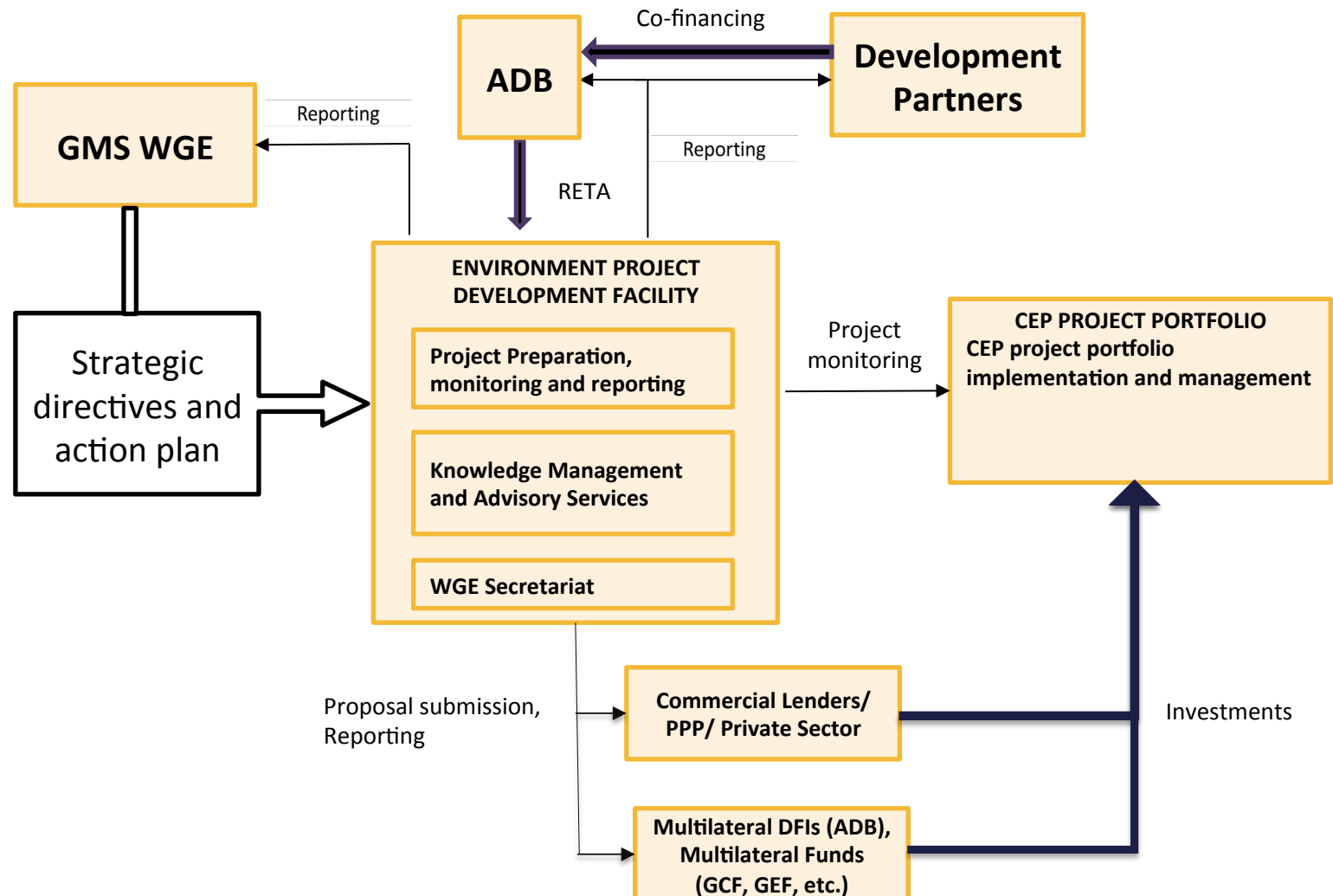
GMS Environment Project Development Facility

- Project preparation/ readiness focusing on:
 - Environment, climate change, and green growth projects
 - CC and environmental mainstreaming in sector projects
- Proposed to be established with a regional TA to develop projects with the potential to:
 - Promote revenue streams and built-in cost recovery mechanisms
 - Leverage PPP and private sector investment
- Will require adjustment in the skillset to meet realigned priorities
