INTRODUCTION

- 1. Under the brilliant and talented leadership of Samdech Akka Moha Sena Padei Techo Hun Sen, Prime Minister of the Kingdom of Cambodia, the country has peace and development in all sectors and many major achievements. Rectangular Strategy Phase II described in detail the priority policies to implement the Government's reform programs aimed at strengthening state institutions, economic and social infrastructure and to create a favorable environment for attracting local and foreign investment in the aim of increasing employment opportunities for people, poverty reduction and development in key sectors of the national economy. To ensure consistency of the Rectangular Strategy Phase II, the government has launched the National Strategic Development Plan Update 2009-2013 for Ministries and Agencies, together implement it during the fourth mandate of the Parliament.
- Based on the Rectangular Strategy phase II and the National Strategic Development Plan update 2009-2013, MoSVY has launched 5 strategies and 6 working priorities for step 2 to promote social welfare, veterans and youth rehabilitation. The 5 strategies include: (i).Transform the provision of social services from humanitarian relief assistance to establishing the social security net (ii). Prepare legal systems and legal regulation to manage and direct social services in accordance with national policies (iii). Mainstream social services to the national development program in all levels (iv). Increase partnership with Cambodian Red Cross, NGOs to conduct fund-raising for humanitarian work and (v).Increase the capacity of institutions, good governance and increase the effectiveness of social services. The 6 working priorities for step 2 include: (1), Strengthen and expand social welfare services for the vulnerable poor; (2). Strengthen and expand child welfare and youth rehabilitation services; (3). Strengthen and expand welfare and rehabilitation services for people with disabilities; (4). Strengthen and expand the social security system and welfare services for the elderly, civil servants and people in general; (5). Strengthen and expand the social security system and welfare services for veterans; and (6). Strengthen and expand institutional capacity, partnerships and fund-raising capacity to increase the effectiveness of social services.1
- 3. As a result, the MoSVY has participated in promoting the well-being of victims and vulnerable of all kinds in society, both spiritual, material that faciliate in providing social services with significant results in the last five years by creating policies, mechanisms, and programs to provide social services to support victims and vulnerable people including: poor victims of natural disasters, other disaster eventually, poor vulnerable people in the communities, dependent elderly, homeless people, persons with disabilities, children of poor families, orphans, children illegal acts, victims of drug abuse, other victims of vicious disease and victim of human trafficking etc. prevention destituteness and vulnerable in society, promoting the fundamental rights of citizens of establish equitable grow in communities. To prepare and implemente policies on social security and programs to

promote the role and well-being of former civil servants and veterans. Meanwhile, the capacity building of Departments and Units, MoSVY has focused on international cooperation in bilateral, multilateral partnerships within the regional and international frameworks. MoSVY has implemented encouraged policy by easing development partners and national and international NGOs to carry out its activities related to MoSVY's works. Since 2011-2013, MoSVY has signed an agreement with Partners 176, with total budget projection of 172.308.864,26 USD, that is about 57.436.288,09 USD annually, which contributes to relieving the burden of national budget as well as mobilizing techniques, human resources, and best practices for social affairs sector.

4. The implementation of the five strategies and six priority programs in the last five years, MoSVY has accomplished major achievements, in the areas of legal frameworks development and the country wide social welfare service provision to the victims and vulnerable people by gaining a lot of experiences, Meanwhile achievements, still, there are many challenges to be solved in the new mandate. To address those challenges, MoSVY has cooperated with all stakeholders to develop it new strategic plan for the years 2014-2018, in order to participate in social insurance and social protection by identifying three strategic goals: (i).Increase the effectiveness of social welfare services (ii).Strengthen and expand the social security system and (iii).Strengthen institutional capacity, and technical and financial resource-raising, for eight priority programs: (1).Enhance welfare for the victims and vulnerable people & family affairs (2).Enhance child wefare and youth rehabilitation (3). Enhance pesons with disability wefare (4).Enhance elderly welfare (5).Enhance civil servant welfare (6).Enhance veteran welfare (7).Create social security system for Cambodian people and (8). Enhance institutional capacity and strengthen partnerships.

CHAPTER 1

SITUATION OF SOCAL AFFAIRS, VETERANTS AND YOUTH REHABILITATION

1.1. Victims and vulnerable people welfare services

MoSVY has created and implemented emergency programs to help victims of natural disasters and other disasters without leaving any population without attention from the authorities. Through this program helped the poor, destituteness, migrants, homeless, people with dementia, victims of natural disasters and other disasters, approximately thousands of families each year. Prevent and reduce the migration for the recovery of livelihoods and community reintegration. Preparing policies and mechanisms for helping homeless people at the national and sub-national levels, in solving problems of street persons for humanitarian aspect and respect the fundamental rights of the victims. A thousand homeless families have been saved and rehabilitated, provide healthcare, mental consulation, vocational training and community reintegration each year. The program to help victims and persons live with HIV/AIDS and other vicious diseases through training, healthcare services and integration to the community. Meanwhile, the MoSVY has established gender working group and through this working group, has disseminated CEDACW convention and mantreaming gender to the officials of the MoSVY,both at national and sub-national levels.

MoSVY has developed policies, minimum standards² and programs for helping victims of human trafficking and to combat human trafficking crime and rescue victims. MoSVY has established bilateral agreements with neighboring countries in the region³ to enhance cooperations to prevent human trafficking and help victims. Victims of human trafficking were rescued and provided services such as: Search families, stay for short and long-term in the centers, forward, integration, repatriation and monitoring. Cambodia received level 2 (TIR2) evaluation on the fight against human trafficking, response to the efforts of the Government. MoSVY has created and implemented programs on the development of family, encourage on building good family, to prevent domestic violence and organize national and international family Day on May 15 and anti-human trafficking Day on December 12, every year. Many families keep traditions happy living in a peaceful society and development.

1.2. Child welfare service

MoSVY has diseminated and implemented the four comprehensive fundamental rights for the children mentioned in the International Convention on the Rights of the Children including: survival rights, development rights, Protection rights and the participation rights. Cambodia has successfully implemented the various target of the Millennium Development Goals related to the child sector such as: reducing maternal and

child mortality rate; education; increase the student schooling rate and quality education etc. and issued and fruitful implementing of child welfare system. MoSVY has created a policy on alternative care for children, minimum standards for the care of children in the center and minimum standards for child care in the community. MoSVY has delegated functions in the area of child welfare system to Capital/Provincial/District/ Municipality/ Khan council and Commune Council. MoSVY has strengthened the quality of the child care in the center, both state and NGOs centers through inspection, reduction in the number of residential care centers that are not applied the standards, family reunification of children according to the principle of giving priority to children receiving development in the frameworks of the family and combined with the implementation of internal adoption and inter-country adoption for children in the centers and community which monitored by MoSVY, to help children who are poor and vulnerable. MoSVY has created the Law on Inter-Country Adoption that approved on 03 December 2009, prepared Prakas on Organization and Functioning of the Central Authority for Inter-Country Adoption of the Kingdom of Cambodia and Prakas on the Organization and Functioning of the Inter-Country Adoption Administration (ICAA). Legal regulations has been developed and circulated to promote the implementation of the Law on Inter-Country Adoption in accordance with United Nations Convention on the Rights of the Child and the Hague Convention on Protection of Children and Cooperation in the respect of Inter-Country Adoption. The capacities of officials and stakeholders has been strengthened through training and dissemination of the Law on Inter-Country Adoption.

MoSVY promoted youth rehabilitation performance by creating and implementing juvenile justice programs to provide legal protection services to juvenile who commit crime in the community and prisons. Prepared draft law on juvenile justice to protect the right of the child in the justice system and prevent the juvenile deligency. Preparing policies and establish National Center of Treatment and Rehabilitation for Drug Addict to help substance abusers and enhance policies to encourage of treatment and rehabilitation substance abusers in communities based treatment. Controlled number of substance abusers are staying in temporary center for rehabilitation to provision of foods. Preparing training plan for training the officers of National Center of Treatment and Rehabilitation for Drug Addict base on the agreement between the National Authority for combating Drugs of Cambodia and the AID, Drug and Prostitution Control committee of the Socialist Republic of Vietnam.

Obligation as a member of the implementation of the Convention of Child Rights Cambodian National Council for Children (CNCC) has prepared and sent National Report 2nd and 3rd on the implementation of the Convention of Child Rights, the 1st and 2nd National Report on the implementation of Protocol on the involvement of children in armed conflict and on the sale of children, child prostitution and child pornography and reports on the implementation of Decision 2009/26 of the Council Economic and Social Affairs of the United Nations on supporting the efforts of national and international, to reform justice children, report on violence against children, report the status of children and National Report on the Implementation of the Protocol involved others to United Nations on time. Compiled indicators child rights 62 indicators divided into 4 part criteria (i)-education, with 10 indicators (ii)-Health and nutrition have 24 indicators (iii)-Good

governance have 17 indicators, and (iv)-Social contains 11 indicators. Strengthen monitoring mechanisms and implementation of child rights by creating working group in the 9 Ministries, Intitutions and CNCC at sub-national level of 24 Municipal/Provinces. Issued guidelines on the implementation of the recommendations of the child rights committee of the United Nations on the implementation of the Convention of Child Rights and diseminated to related ministries, institutions and organizations and trained on laws, policies related to the protection of the rights of children affected by trafficking to the official of CNCC at sub-national administration of 12 provinces.

Preparing child participation guideline, research, study, analyzes the gap of the legal framework relating to child protection, compiled laws, policies and legal regulations concerning the protection of children. CNCC in collaboration with other relevant institutions organized 1 June International Children's Day and World Day Against Child Labour, 12 June, with 3,000 participants each year. Prepared Newsletter of children situation, CNCC newsletter, CNCC website, Program Roundtable Discussion, child forum examination short text editor program relating to child rights, short educational video, child art television and leaflet related to child rights.

1.3. Persons with disabilities welfare service and rehabilitation

MoSVY has developed law on the Protection and the Promotion on the Rights of Persons with Disabilities in accordance with the national policy on persons with disabilities. Through this law, policy on promoting the rights of persons with disabilities and eliminating discrimination toward persons with disabilities, has been widely and fruitfully implemented as well as increasing opportunities for persons with disabilities participate in all social activities. Ministry has established mechanisms such as the Disability Action Council (DAC) to coordinate, advice, monitor the disability sector and Persons with Disabilities Foundation (PwDF) has to raise fund and provide services to persons with disabilities in accordance with the law on the Protection and the Promotion on the Rights of Persons with Disabilities . MoSVY has collaborated with NGO partners⁴ produced assistive devices prosthetics and orthotics and walking aids, wheelchairs, provide physiotherapy and medical rehabilitation service to persons with disabilities free of charge and continued sustainability in providing physical rehabilitation to persons with disabilities more than 20,000 people each year, including the provision of transportation, accommodation and food. Develop policies on supporting the poorest of persons with disabilities in the community.

MoSVY has also organized and implemented a Community Based Rebabilitation (CBR) for persons with disabilities, provided rehabilitation services, formed self-help groups and developed small business. Encouraged the formation of the organizations of persons with disabilities led by persons with disabilities such as the Associetion of the Blind in Cambodia (ABC), Cambodian Disabled People's Organization(CDPO) and the National Centre of Disabled Persons (NCDP), and self-help groups of persons with disabilities in the communities of 1,950 groups and employment opportunities have been provided to

persons with disabilities by determining the quota of persons with disabilities at the government institutions 2 persent and private setors 1 persent.

Established programes to provide services for the Blind, deaf children and children with Intellectual disabilities through the creation of centers to provide special services to each disabled children and integration of children with disabilities into the communities without discrimination. Encouraged arts and sports movement of persons with disabilities, information in sign language and development of braill and sign language services. Cambodia has ratified the Convention on the Rights of Persons with Disabilities, adding to the existing national legal frameworks. Participated development and adoption the Person with Disabilities decade for Asia and the Pacific 2013-2022, Incheon Strategy "Make the Right Real".

1.4. Social security system and welfare services for the elderly, civil servants and general peole.

MoSVY has developed and implemented national policies for the older people. The rate of the adults aged 60 years old and higher in total population is 6% which will be dramatically increased in line with the demographic characteristics, the improvement of welfare sector and the national economic development. To implement policies for the older people and organize annually the 1st October older people's Day, MoSVY has established the Cambodia National Committee for Older People and sub-national body mechanisms. MoSVY has implemented two main important programmes: (1)-The community older people development program and (2)- programme of family based care for the older people. There were 569 older people's associations established at the communes/sangkats level and their activities were programmes of health care, rice bank, cow bank, micro-credit, fund for death family and solidarity action that the elderly can help each other in the community. These programmes help the older people in health care to make them long life that they can provide their contribution in the development of the country. Meanwhile, MOVSY has encouraged the implementation of the programme of family based care for the older people by the dissemination of the good traditions and good customs in Khmer families in respect, in gratitude for older people, included parents, grandparents and so on. MoSVY has also encouraged communities and religion temples, especially temples of Buddhism and of other religions to help the older people followers who stayed and took those places as their asylums. Numbers of generous people have created a humanitarian programme to help older people, such as the programme of "Goddess Houses" of Bayon television stations which built hundreds of houses for the poor older people in the communities. MoSVY has prepared the draft of law concerning the Social Security for general Cambodian people and the review of that draft which will be submitted for adoption for implementation from 2014-2018.

MoSVY has implemented national policies for former civil servants to express its gratitude to their contribution to the cause of the country development, left their achievements and their best practices for the new generation. MoSVY has made them motivated by offering them the honor, the dignity and provide them the Social Security which was successively adjusted in accordance with the national economy availability. MoSVY has established and has put in place the social security for the civil servants which

included 6 benefits such as retirement, invalidity, maternity, work injuries, death and dependents. The social security for civil servants was increased every year in accordance with the civil servant salary increase. MoSVY has established and implemented the National Social Security Fund for Civil Servants (NSSFC) to pay social security on time in accordance with the public service provision policy and the national strategy on the public financial reform. Until today, the national social security fund for civil servants has implemented the pension payment through banking systems in Phnom Penh and 14 provinces, and will continue to expand the implementation in the entire Cambodia in early 2014, for about 45,000 retirees and invalids as beneficiaries.

1.5. Social security system and welfare services for veterans

The Royal Government of Cambodia has taken seriously attention to the veterans and implemented national policy for veterans with respect the merit critical of veterans for serving the national and people with attention to livelihood with series support both material and budget and honors respect and maintain dignity to veterans. More attention of revising a series of allowance support to veterans in accordance with the actual situation of the national economy (By the end of 2013, increasing the percentage of present base allowance by ranking to 235 perscent)⁵. Computerize all veterans and families information system to manage data and provide social security to veterans through a bank system to increase the effectiveness of the payments of the social security fund to veterans and their families. Updated all veterans and families information system to manage data and provide social security to veterans through a Banking system to increase the effectiveness of the payments from the social security fund to veterans and their family. Until the end of 2013, the Veterans and families of 20 Municipal/Provinces⁶ has received monthly social security payments through the banking system and implemented entirely in the mid of 2014. Meanwhile, MoSVY has implemented a policy of social land concessions to the former armed forces and their families and has developed several projects to improve the living standards of soldiers and veterans.⁷

Cambodia Veterans Association (CVA) was established on 21 June 2007, during the general assembly of CVA and become a member of Federation of ASEAN Countries in the 13rd Veterans Federation of ASEAN Countries which held on 25th -28th April 2010 in Jakarta of Indonesia. CVA has achieved remarkable success⁸ in improving standard living, local development, creating credit funds and death rescue fund, house construction and veteran community development. Samdech Akka Moha Sena Padei Techo Hun Sen and Samdech Keti Prit Buntit, had build center development of disabled soldiers at Taken Koh Sla, Chhuk district in Kampot province, center development of disable soldiers 317 Kulen in Siem Reap province and center development of disable soldiers Phnom Chhat in Banteay

Meanchey province and some other regions. Meanwhile, Samdech Techo **Hun Sen** and Samdech Keti Prit Buntit constructed home for the veterans and their families in the community through the CVA, total 184 houses and continuing to build others.

1.6. Strengthen and expand institutional capacity, partnerships, and fund-raising capacity to increase the effectiveness of social services

National budget for social sector is gradually increased every year with 258,249,340,000 Riel in 2011; 353,187,800,000 Riel in 2012; 772,810,176,000 Riel in 2013. This increasing, indicates that MoSVY has correctly managed payments on time to all targets beneficaries in resposibility, efficiency, transparency and with a clear plan.

Inspection and Internal Audit department has conducted audit and guidance to the provincial departments on the income and expenditure of state budget and CVA. MoSVY has cooperated with Ministry of Economic and Finance's audit team to conduct audit of allowance of the victims of addictive substances in the Rehabilitation Center for victims of the arbitrary use of addictive substances in Phnom Penh, Preah Sihanuk, Battambang, Banteay Meanchey and Siem Reap provinces.

MoSVY continuously develop Institutional capacity building, and training officials who works in the field of Social Affairs, Veterans and Youth Rehabilitation with good quality for them to perform tasks defined in the future. MoSVY has conducted 32 training courses, including: 4 Basic Social Services Training (BSST), 4 Professional Social Services Training (PSST), 15 Counselling and Psychosocial Skill, 5 courses on working with trafficking victims and care of children orphaned and vulnerable children, those training was participated by total 724 trainees. Some officials were trained abroad through workshops and study tours. The RGC issued a sub-decree on the establishment of the National Institute of Social Affairs (NISA). Until the end of 2013, NISA has 179 students who are doing undergraduate degree. 76 students are doing their Bachelor of Social Work (Year 1=53 student and Year 2=23 students), 19 students are doing their Bachelor degree of Sociology 19, 45 students are doing their Bachelor degree of Social Protection, and 39 student are studying their Bachelor degree of Prosthesis and Orsthetics Engineeing (year 1=19 years, year 2=07 students and year 3=3 students). The Porsenchey social development center and Banteay Preab received 163 students (69 women), study on motorcycle repair, Radio, garment ,TV and computer skills. To create a website⁹ and enter data, including: organizational structure of the MoSVY, regulation, 5-year work flatform, quarterly report, 9 months report and 5 years report, Laws, Royal Decrees, Sub-Decrees and data of the NGOs in cooperation with MoSVY.

With supporting from the National Committee for Sub-national Democratic development (NCDD) and UNICEF, the MoSVY's Decentralization and De-concentration working group (D&D-WG) was established and achieved in the followings: study on processedure and coordinate on transfer functions to sub-national administration¹⁰ and conducted interview and data collection at MoSVY and Sub-national administration for

preparing function mapping report.¹¹ A report on the functions mapping of the MoSVY, has been submited to NCDD for reviewing and recommendation and this report was approved by NCDD on 12 November 2013. The D&D-WG has prepared function review report.

MoSVY has focused on international cooperation in bilateral, multilateral partnerships within the regional and international. MoSVY has implemented encouraged policy by easing NGO parters to carry out its activities related to social affairs, veterans and youth rehabilitation, including: provide land use, building, sharing operational costs, facilitate import without taxes and the state's tax burden and other cooperation. Since 2011-2013, MoSVY has signed an agreement with NGO Partners 176, with total budget projection of 172.308.864,26, that is about 57.436.288,09 USD annually, which contributes to relieving the burden of national budget as well as mobilising techniques, human resources, and best practices for social affairs sector.

Cambodia hosted the 8th ASEAN Ministerial meeting on social welfare and Development and the 4th ASEAN Ministerial meeting plus 3 and related meetings in Siem Reap province from 3-7 September 2013. The ASEAN Ministers adopted a declaration on strengthening social protection and the declaration on the elimination of violence against women and the elimination of violence against children in ASEAN, that documents related to social welfare and development sector were submitted and adopted in the 23rd ASEAN Summit in Brunei Darussalam.

CHALLENGES

- 1. Meanwhile, the achievements mentioned above, Cambodia also has many challenges include poverty, uncertainty of the global economy, the exacerbated by climate disasters and other disasters, has created a vulnerability, such as migrants, homeless, human trafficking, drug consumption, lonely elderly, person with disability, and orphans and vulnerable children.
- 2. According to the 2008 census, there are children under the age of 18 years is 41percent (5.487.708) of the total population. Among the children has orphans and vulnerable children about 14 percent (750,000) are living in residential care centers, living with the poorest families or living in a household head. Orphans and vulnerable children are facing sharply to the vulnerability, such as: lack of food, nutrition, mental health crisis, no education or late schooling, HIV/AID infection, drug use, sexual exploitation and labor trafficking.
- 3. Law and regulation enforcement in the field of Social Affairs, Veterans and Youth Rehabilitation limited, Meanwhile, the shortage of officers and social workers for providing social welfare services.

CHAPTER 2 STRATEGIC FRAMEWORK

This Strategic Plan has been developed by the MoSVY in consultation with stakeholders working in the Social Affairs, Veterans and Youth Rehabilitation sector. Development of this Strategic Plan is based on, the experiences and results in the past, filling in the gaps and improving the Social Affairs, Veterans and Youth Rehabilitation sector. This Strategic Plan reflects the vision of the Ministry for Social Affairs, Veterans and Youth Rehabilitation sector for the next 5 years 2014-2018.

The Strategic Plan aims to achieve the goals set in the policy documents, such as: (1). The Government's political aims for the 5th of Parliament¹² (2).Rectangular Strategy Phase III¹³ (3).Development Strategic Plan (NSDP) 2014-2018 (4).National Social Protection Strategy for the Poor and Vulnerable (NSPS)" 2011-2015 (5).Millennium Development Goals (6).Multi-sector strategic plans of the Ministry¹⁴. This Strategic Plan is responsive to: (1).Strategic plan in accordance with the ASEAN Framework, ASEAN plus three (2).Madrid Action Plan on the elderly (3). Convention on the Rights of Persons with Disabilities (CRPD) and the adoption of the Asian and the Pacific Decade of Persons with Disabilities 2013-2022 and the Incheon Strategy to "Make the Right Real", in 2012. (4).Convention on the Rights of the Child and (5). Other related conventions and legal frameworks etc.


This Strategic Plan also contributes to the country policy agenda on improving the effectiveness of financial cooperation by providing a framework to ensure ownership and leadership of the RGC and development partners and national and International NGOs cooperation oriented to the strategic plan, its programs and indicators. This mechanism lead to performance management approach for the social affairs, veteran and youth rehabilitation with sustainable in the management of resource for social welfare services.

2.1. Vision

"Moving social welfare services close to the victims and vulnerable people and strengthening the social security system"

2.2. Mission

The MoSVY mission is to provide social welfare services to victims, vulnerable and the poor such as: the elderly, persons with disability, homeless, orphans, street children, women entertainment service, people living with HIV/AIDS and and in addition to provide social security for former civil servants and veterans in an equitable and transparent manner.

2.3. Strategic Goals

2.4. Institutional and Coordination

2.4.1. MoSVY established by law, promulgated by Royal Kram 001, dated 17 January 2005. Sub-Decree No. 54, dated 24 March 2011 on the management and functioning of the MoSVY and clearly defined functions and responsibilities of the General Department, General Inspectorate, Departments and Units under the Ministry. Meanwhile, the MoSVY is responsible to the Head of the Government. In this regard, the Ministry is responsible for coordination and implementation of Social Affairs, Veterans and Youth Rehabilitation and monitoring the implementation of the Strategic Plan for 5 years (2014-2018).¹⁵

2.4.2. PoSVY established by Prakas No. 359 MoSVY, dated 16 August 2005, a line department of Ministry, is responsible for coordination and implementation of Social Affairs, Veterans and Youth Rehabilitation at the sub-national administration which assist from DoSVY. Currently MoSVY delegate some functions to PoSVY, to implements on behalf of the Ministry and in the future, MoSVY will gradually transfer functions directly related to providing social welfare services to the sub-national administration, so the PoSVY and DoSVY officers office are directly implemented those functions under the coordination of the sub-national administration.

2.4.3. The other stakeholders who contribute in the field of Social Affairs, Veterans and Youth Rehabilitation, including the Ministries, Institutions, Cambodian Red Cross, Development Partners, Nationa and International NGOs, private sector, sub-national administration, and those who receive social welfare services, will support and cooperate with the MoSVY to implement the this strategic plan in effective and efficient manner.

2.5. Priority programs and implementation measure

2.5.1. Enhance welfare for the victims and vulnerable people & family affairs

MoSVY will increase social intervention to help the poor vulnerable, migrants, homeless persons, mental retardation and victims of natural disasters, and not let the people who died of famine, which we did not know and did not address. MoSVY will continue to expand the program to help the poor and vulnerable, address the vulnerability of poor people in the community, and prevent destitution and high-risk migration. MoSVY will continue to address the problems of street persons, recognize street person as victims needing social protection, providing services to street persons based on the principle of respect for human rights and providing a chance to restore livelihoods and reintegration into society. MoSVY will increase assistance to persons live with HIV/AID and other vicious diseases. MoSVY will promote the fight against human trafficking and assist victims through rehabilitation and/or vocational training and reintegration of the victims back to the community without discrimination for responding to the need of vulnerable people as priority. MoSVY will continue to implement the policies and minimum standards on the protection of the rights of victims of human trafficking and related legal frameworks and continue to organize anti-human trafficking Day on December 12. MoVY will continue to develop good family movement, prevention of violence in the family and promote the role of the family as the cell of society where warm and happiness for all people contribute to social development. MoSVY will continue to organize family day on May 15 every year To expressed respect family appreciated those efforts nurture the care of children to become good citizens in society. Continue to mainstreaming gender to the Social Affairs, Veterans and Youth Rehabilitation official at the national and sub-national levels. MoSVY will prepare and implement policies on the development of the poor communities in the communities to make available opportunities for changing living condition.

2.5.2. Enhance child welfare and youth rehabilitation

MoSVY will continue to promote the dissemination and implementation of the International Convention on the Rights of the Child, especially the four basic rights of children survival rights, development rights, Protection rights and the participation rights". MoSVY will continue to achieve the Millennium Development Goals related to child welfare sector by supporting policy on alternative care for children, minimum standards on residential care for children in the community and minimum standards of community and family based care. Continuous improvement of the state and NGO residential care centers through inspections, to reduce the number of centers that does not meet minimum standards on residential care for children, family unification on the principle of giving priority to the child's development within the family principles improvement, reduced the number of centers. Continue to dissemination and implementation the Law

on Inter-Country Adoption, and legal regulations to contribute to further strengthen of the government's policy on promoting child welfare nationwide by attention to place the child in domestic by trying all possibilities of adequate support before inter-country adoption in the aim of humanitarian to find good family for child and to ensure the best interests of the child. Strengthen cooperation with states party to the Hague Convention and the countries with the cooperation adoptions from Cambodia to prevent the trafficking of children in form of an inter-country adoption and continue to strengthen the capacities of the officials and stakeholders through training and assign officers to attend the meetings and training courses to exchange work experiences and the adoption procedures are implemented the cooperation countries in the field of inter-country adoption in Cambodia. Implementing the foster care program in the residential cares and communities to help children who are poor and vulnerable. MoSVY will promote the implementation of youth rehabilitation and implement juvenile justice programs, continue to provide legal service for juveniles committing crimes in community and prsions. MoSVY will promote the adoption of the draft law on juvenile justice to protect the rights of the child in the justice system and prevent juvenile deliquency. Strengthen the responsibility to supporting, caregiving and rehabilitation drug addicts at center and community, the capacity building treatment centers and rehabilitation of drug addicts to facilitate the implementation of policies, care, rehabilitation and referal drug addicts to communities and increase the mechanisms of monitoring of implementation of supporting, treatment, care, rehabilitation of drug addict families in the community and establish the National Center of Treatment and Rehabilitation of Drug addict. Continuing obligations as a member of the convention on the rights of the child, preparing 4th to 6th national report on the implementation of conventions on the rights of the child and preparing national report on the implementation of relevant optional Protocol to the United Nations on time in a professional maner. Continue to implement the national strategic plan on orphans and vulnerable children 2013-2018 and strategic planning of the National Council for Children 2014-2018.

2.5.3. Enhance persons with disability welfare

MoSVY will promote the implementation of the Law on the Protection and the Promotion of the Rights of Persons with Disabilities in accordance with the national policies on persons with disabilities. Through the Law on the Protection and Promotion of the Rights of Persons with Disabilities, will promote the implementation of policies promoting disability rights and the elimination of discrimination for persons with disabilities as well as opportunities for persons with disabilities to participate in all activities of the society. Continuing to deveop policies and legal frameworks relating to the welfare of persons with disabilities. Continue to function the Persons with Disabilities Foundation (PwDF), in mobilizing fund and provide services to persons with disabilities in accordance with the Law on the Protection and the Promotion of the Rights of Persons with Disabilities. To continue sustainability of rehabilitation programs for persons with disabilities, free of charge, including travelloing cost and staying in the period of rehabilitation. Enforce support policy for poorest persons with disabilities in their community, in according to the availability of funds. Continue to implement community programs for persons with disabilities, provide rehabilitation services, forming self-help groups, small business

development. Encourage the establishment of Persons with Disabilities organization led by peersons with disabilities such as Associetion of the Blind Cambodia, Cambodian Disabled People's Organization (CDPO). The National Centre of Disabled Persons (NCDP), and self-help groups of persons with disabilities in the community. Provide employment opportunities for persons with disabilities, 2% in Government institutions and 1% in Private sector defined by the law. Promotes accessibility at public places for all persons with disabilities. Continue to provide services to blind children, deaf children and children with intellectival disabilities through education and special services to each type disabled children and integrat them into the community without discrimination. Encourage sports artistic and sports movement of persons with disabilities, information in sign language and develop braill and sign language. Promote the dissemination and implementation of the Convention on the Rights of Persons with Disabilities, adding to the existing national legal frameworks. MoSVY will promote the implementation of the National Disability Strategic Plan (NDSP) 2014-2018 and Persons with Disabilities Foundation Strategic Plan 2014-2018.

2.5.4. Enhance elderly welfare

MoSVY will continue to implement the national policy for older people and continue to review this policy in accordance with the national economic situation, in considering the older people as valuable resources of a society due to their achievements and heritages which they left for the new generation and society. The rate of the adults aged 60 years and up is 6 percent of the total population. This rate will rise steadily in line with the progress of the welfare sector and the development of national economy. MoSVY has promoted activities of the Cambodian National Committee for Older People (CNCOP) and the sub-national body mechanisms in implementing of policies for Older People included organizing Older People's Day on 1 October each year. MoSVY will continue to implement the two main programs which are: 1-The Older People in the community program and 2-Family care for the Older People program. MoSVY Continued to strengthen the establishment of the Older People's association program in Communes/Sangkat to create a platform of health care, rice bank, cow bank, Microfinance, death fund saving and solidarity between the older people in helping each other in the same community, to make them healthier and long life that they can contribute to the country development. MoSVY continued to promote family care for older people through dissemination of the good tradition and good customs in Khmer family in gratitude, in respect to the older people, including parents, grandparents and so on. MoSVY will continue to encourage the community, religion temples, especially those of Buddhism and of other religions to help the older people followers who took those places as their asylums. MoSVY Continued to encourage donors to create a humanitarian program to help the older people, such as constructed and provided homes for the poor older people in the community and continued to encourage the high rank dignitaries, generous people, authorities at all levels to express their concerns in providing humanitarian donation such as gift, material, and finance to the poor vagrant older people in the communities. MoSVY has prepared and implemented the functioning of the Older People service centers and has trained the personnel or agents on care service provision for them. MoSVY continued to encourage the government, NGOs and the private sector in setting up the health care for older people.

2.5.5. Enhance the social security fund for civil Servants (NSSFC)

In accordance with national policies on the provision of public service to former civil servants, NSSFC continues to implement social security schemes based on good governance principles, transparency, and high responsibility in order to response to the gratitude of former civil servants who serve the nation and contribute in country development; leaving good experiences and achievements for next generations. To continue to encourage them through giving honors, dignity, and social security schemes with gradual adaptability of the national economic possibility. NSSFC provides social security services, which covered six benefits including retirement, invalids, maternity, work injury, death, and their dependents. Due to the increase in scope of work and its size, NSSFC will lease a new location for temporary office and will search for land purchase and propose of having a headquarter construction in Phnom Penh. The NSSFC has finished its first phase of registration for beneficiaries within 25 municipality and provinces and it continues to register new beneficiaries. From the end of February 2014, all beneficiaries will receive monthly payment of pensions via banking system. In order to facilitate the process of providing services to the beneficiaries, NSSFC will establish its branches located in city, khan, and district throughout the country according to circumstances and the necessity. The preparation of inter-ministerial Prakas between the parental ministries of NSSFC on the implementation of contribution rate of 24% of active civil servants will be finished in earlier 2014. Contribution rate of 24% of total monthly salary will be borne by the government at 18% and another 6% will be borne by the individual civil servants. However, currently for the six percent, the Royal government under leadership of Samdech Techo HUN SEN, prime minister of Kingdom of Cambodia pays on behalf of the civil servants within this 5th and following mandates. To improve efficiently and effectively the data management of civil servants, NSSFC will connect its IT system with the Ministry of Public Function and its bank partners. Moreover, it will become a public administrative institution with technical and financial autonomy.

2.5.6. Enhance veteran welfare

Continue to attented revising social security scheme for veterans in accordance with the situation of the national economy. Promote the National Veterans Fund (NVF) to carry out the management of funds and ensure social security, veterans and families effectively by continuing social security to veterans of 9 benefits: retirement, maternity, invalidity, first marriage, sacrifice, death, disability, sickness and their families. Continue to implement the policy of social land concession to former armed forces and their families and develop several projects to improve the living standards of soldiers and veterans. Development of Cambodia Veterans Association (CVA) to assist veterans in promoting family living standards, to participate in local development. Continue to Proceeding death rescue fund, house construction, veterans development community. Make it easier for veterans to get vocational training and the provision of social land concession etc. MoSVY will continue to sustainable Center development of disable soldiers at Taken Kohsla, Chhuk district in Kampot province, Center development of disable soldiers 317 Kulen in Siem Reap province and Center development of disable soldiers Phnom Chhat in Banteay province and some other regions and continue to construct houses for poorest veterans and their families in the community through the CAV. Continue to organize the Veterans Day 21th June each year.

2.5.7. Study on social security system for Cambodian people.

Study on social security system covering the scope layers of all segments of society as the core of the social safety net.

2.5.8. Enhance institutional capacity and strengthen partnerships

MoSVY will continue to build institutional capacity, strengthening partnerships and professional manners consciousness and increase social capacity at all levels in response to the tasks at this new phase. Increase the support to National Institution of Social Affairs (NISA) for training human resource of the government institutions, private sectors, and NGOs involved in providing social services, increase research and expand other program skills on both higher education and certificate levels. Promote disemination of policies, legal frameworks and regulations of Ministry to sub-national and stakeholders. Continue to implement the reform program on all parts in accordance with the Government's policy to improve the effectiveness of social welfare services. Continue to implement the program of decentralization and deconcentration reform through the transfer of functions and resources to the sub-national administration step by step. Continue to implement the reform of public finance. Continue to strengthen partnerships with national and international NGOs, to extend the spirit solidarity in society and mobilize resources, budget, equipment and techniques for the requirement of social welfare, help the victims and vulnerable and poor through building coordination mechanism, including encouraging national, international NGOs and development partners to interact on social sector and paying attention to the officials who working on sector too. Promote engagement welfare activities with ASEAN including are pillars of ASEAN Socio-culltural community, social welfare and development, Enforcement efforts with ASEAN road map, blueprint, monitoring and evaluation through the score card of the ASEAN socio-cultural community.

CHAPTER 3 RESOURCE REQUIREMENTS

- 3.1. MoSVY have received a budget allocation from the Royal Government of Cambodia over the last 3 years (2011-2013) of 1,384,247,316,000 Rield¹⁶ (346,061,829 USD) for expenditure on the purchase of external services, salary and taxes. According to data analysis and discussions with experts, showed clearly that the management of the budget of the Ministry really served the request and the need to address the difficulties that the number of victims and vulnerable are reduced continuously and directed beneficaries received the service as reliable. These activities also follow the chapter¹⁷ and reflects to the implementation of its budget as well.
- 3.2. MoSVY has focused on international bilateral and multilateral partnerships and cooperation within the ASEAN Region and Global, MoSVY has implemented encourage policy by easing NGO partners to carry out its activities related to Social Affairs, Veterans and Youth Rehabilitation. Since 2011-2013, MoSVY has signed agreements with 176 Partners with total budget projection of 172,308,864.26 USD, that is about 57,436,288.09 USD annaully, which contributes to to relieving the burden of national budget as well as collecting techniques, human resources, and best practices for Social Affairs ,Veterans and Youth Rehabilitation¹⁸.
- 3.3. To implement a 5-year strategic plan 2014-2018 and annual budget forecast of growth averaging about 10% of this budget in order to meet the needs, a government source 862,739,764.46 USD¹⁹ and budget participation of NGOs 287,181,440.45 USD.

CHAPTER 4 MONITORING AND EVALUATION

- 4.1. To implement the Strategic Plan 2014-2018 by achieving the objectives and targets of the defined indicators, MoSVY has created a specific monitoring and evaluation system to measure progress. The monitoring and evaluation of the activities carried out are important work in the planning process. MoSVY has developed an action plan with comprehensive consultation and based on the 2014-2018 strategic plan of the MoSVY. Meanwhile, the Provincial Department of Social Affairs Veteran and Youth Rehabilitation (PoSVY) will develop strategic plan, annual action plans based on the MoSVY Strategic Plan 20014-2018. PoSVY Strategic Plan and Annual Action Plan will set strategic targets and indicators for specific activities to be carried out.
- 4.2. The procedures of monitoring and evaluation will be carried out in three phases: the 1st phase is at the end of each year, 2nd phase is in the mid-term review (2nd Semester of 2016) and the 3rd phase is in 2018. MoSVY will set up mechanisms for data collection and analysis to measure the achievements. Department of Planning, Statistics and summing-up is a core of monitoring and evaluation on the implementation of this Strategic Plan in collaboration with other departments and all relevant stakeholders. Departments, Units and all stakeholders that work in the field of Social Affairs, Veterans and Youth Rehabilitation are giving a high priority to the regular monitoring and evaluation on the implementation of the program, project and its action plan.
- 4.3. MoSVY's Strategic Plan 2014-2018 is an important roadmap for the Departments, Units and other stakeholders in the field of Social Affairs, Veterans and Youth Rehabilitation which is responsible for monitoring and evaluation to improve gradually in a fashion that is appropriate to the current context of the country.

CONCLUSION

- 1. Strategic Plan 2014-2018 of MoSVY, developed in 2013 under the direction oriented from the Minister and the participation of the Working Group, Departments and Units by facilitation and comprehensive consultation with relevant partners in the field of Social Affairs, Veterans and Youth Rehabilitation.
- 2. This Strategic Plan is the Roadmap for implementing strategices, programs and mission of the MoSVY, to contribute to the government's political program of the 5th Parliament, Rectangular Strategy Phase III, and the National Strategic Development Plan 2014-2018.
- 3. This Strategic Plan has a clear vision in promoting social welfare for the people, as well as those who receive Social Security from the RGC, especially victims and vulnerable peole and to promote a living standards, prevent the vulnerability of peole, increasing social intervention to help the poorest people in the society and to provide a chance to receive the fruit of equitably development. Strengthen the existing social security system and expand the social security system to covering all segments of society as the core of the social safety net. Moving the social welfare services closer to the victims and vulnerable and people, to improve the quality of service delivery to be transparent, accountable and effective response to the need of the beneficaries.
- 4. This Strategic Plan is a new strategic framework for Social Affairs, Veterans and Youth Rehabilitation, which is covering the implementation projects and related activities. This Strategic Plan requires a participation and commitment from the RGC and support from related partners and other donors. This Strategic Plan will make a harmony between the MoSVY's programs with the Development Partner's programs involved in the field of Social Affairs, Veterans and Youth Rehabilitation. This Strategic Plan will respond to the request of the related partners and help to address the challenges to achieving the strategic goals and indicators for effectively and efficiently.
